- Top / bottom paper - testliner
- Corrugate layer – flutes,

Regardless of the grammage of the resources, it is always in accordance with the following provisions:

Directive 94/62/EC, requirements of the Law on the management of packaging and packaging waste of 13 June 2013, in respect of heavy metals quantity limit, i.e. sum of the contents in the products do not exceed 100 mg/kg, as well as harmonized standards PN-EN 13428:2007 and PN-EN 13430:2007,



Recommendations concerning food packaging

The direct contact of food products with corrugated board packaging should be prevented by applying barrier materials intended to come into contact with food.

Every packaging should contain the following information (labeling*)

- the address of registered office of the manufacturer, processor or seller
- Identification details (batch number)
- "Disposable packaging"

Moreover, the packaging of the food articles sold hot (e.g. pizza, pie) should contain additional information:

- "the packaging is used for transport and is not intended to store food for longer than 1 h".

* Labeling in accordance with Art. 15 of the Regulation (EC) No. 1935/2004 of the European Parliament and of the Council of 27 October 2004 on materials and articles intended to come into contact with food.

This certificate of compliance has a validity of one year
