Declaration of compliance

For plastic materials, which are in contact with food

We hereby confirm that following listed products comply with the legal regulations laid down in the European Regulation (EU) No 10/2011 as well as in Regulation (EC) No 1935/2004 – both as amended.

Debabag (flat bags)

When used as specified, the overall migration as well as the specific migration do not exceed the legal limits. The testing was performed according to Regulation (EU) No 10/2011 (Annex V).

The materials and raw materials used comply with Plastic Regulation (EU) No 10/2011; no substances subject to limitations and/or specification (Annex I and II) have been used in the above mentioned product.

Note on dual use substances:

The PE used may contain substances that are also approved for use as food additives:

- Silicium dioxide

Due to the overall migration limit (60ppm), it seems very unlikely that a food additive used as a plastic additive will compromise the compliance with the regulatory threshold for this additive in the food product. In case an additive is used in a quantity approaching the maximum level in food, we will discuss this situation with the producers of the raw material.

Specification of the intended use or restrictions:

- Type or types of food or processes for which the material is suitable:
Dry, moist or greasy food products
- Type or types of food or processes for which the material is not suitable:
Not suitable for hot filling/in-pack sterilization
- Test results:
Test conditions: temperature 40°C, time: 10 days

- Ratio of food contact surface area to volume used to determine the compliance of the material or article:

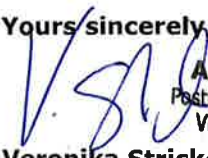
Surface to volume ration = 6 dm² /kg food

No functional barrier made from plastic is used in the above mentioned product.

Traceability of the product is ensured according to Regulation (EC) No 01935/2007 via control labels including details on the production order numbers (= load number, order number and control number).

This declaration is valid for the product as described and delivered by us. The verification of compliance was performed based on the rules set out in Regulation (EU) No 10/2011; according to which the product complies with the legal requirements subject to adherence to the stated conditions for the contact with food. In case of deviating food contact conditions, it is up to the user to verify the suitability. In particular it is emphasized that in the case of printed material, no contact is allowed between the printing ink and the food product.

Our declaration is based on the data of our previous suppliers. Although the substances which are subject to limitations in above mentioned regulations are not used or added on purpose, the presence of negligible hints caused by e.g. contamination can't be excluded fully. As the appearance of those substances is seen as very unlikely, we abandon a chemical investigation to prove their absence due to economical reasons.
